Program: Track 1

Program Description

We will offer the Track 1 content in a video series that will consist of three modules. Each module will offer a selection of video sessions that participants will review over a two-week period. There will be readings that go along with these sessions and discussion questions to complete. Participants will then join Gideon's Promise faculty for a virtual Zoom debrief of the materials for that module. The three-module program will run from October 7th through December 20th with a final Track 1 virtual debrief wrap-up on December 12th.

The Track 1 virtual program is designed to provide participants a deep understanding of the philosophy guiding our curriculum and how we structure our two-week Core 101 Summer Institute training. Participants will learn the types of sessions we teach at Summer Institute, why we teach them, and how we run the sessions.

Participants who complete Track 1 will be eligible to register for Track 2, an in-person program through which participants will be coached in interactive small group workshops to learn how to teach select Summer Institute sessions described in Track 1. Track 2 will be offered in Atlanta, GA this coming January, 2025.
